

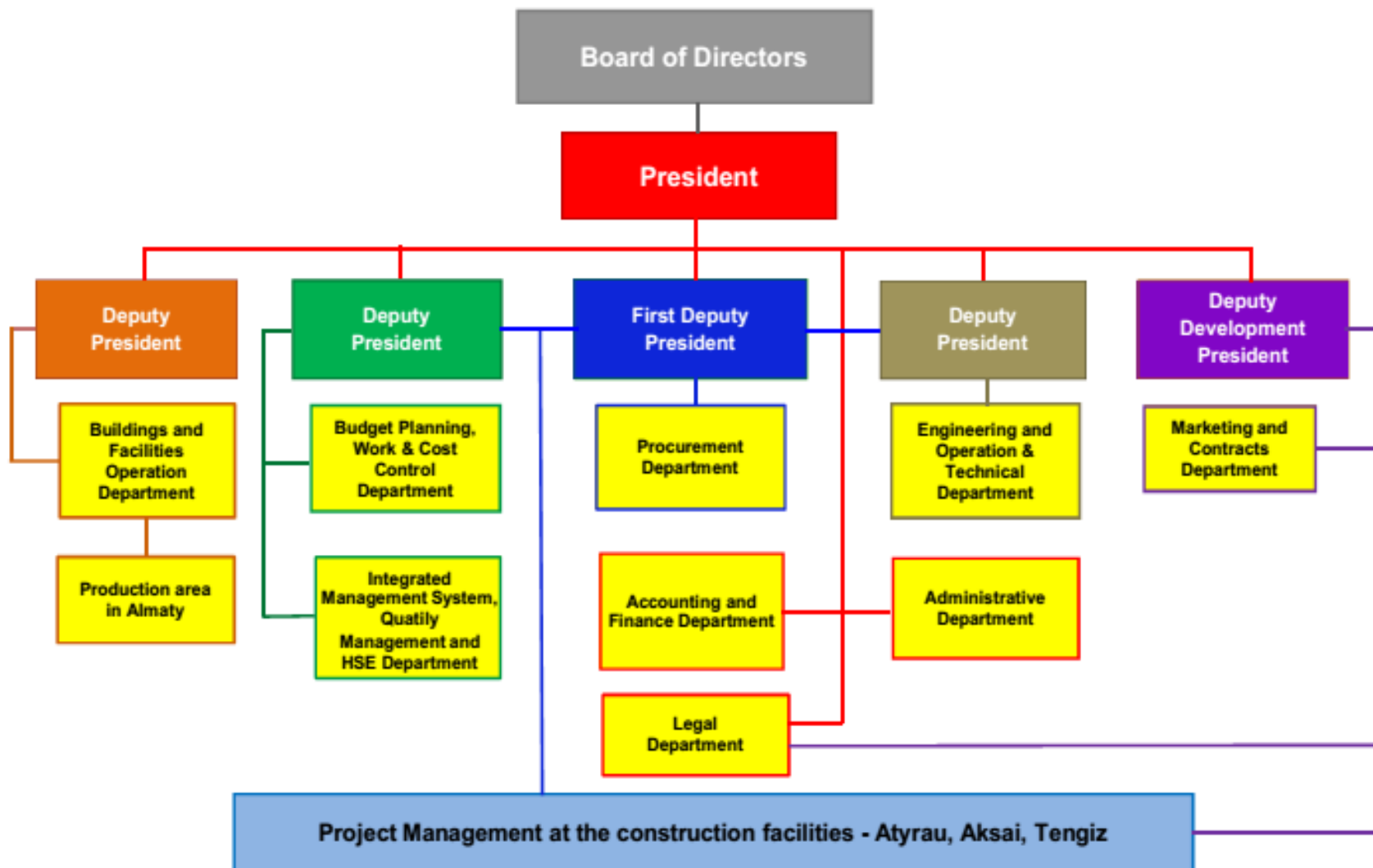

- warehouse premises - **2 400 m2**.

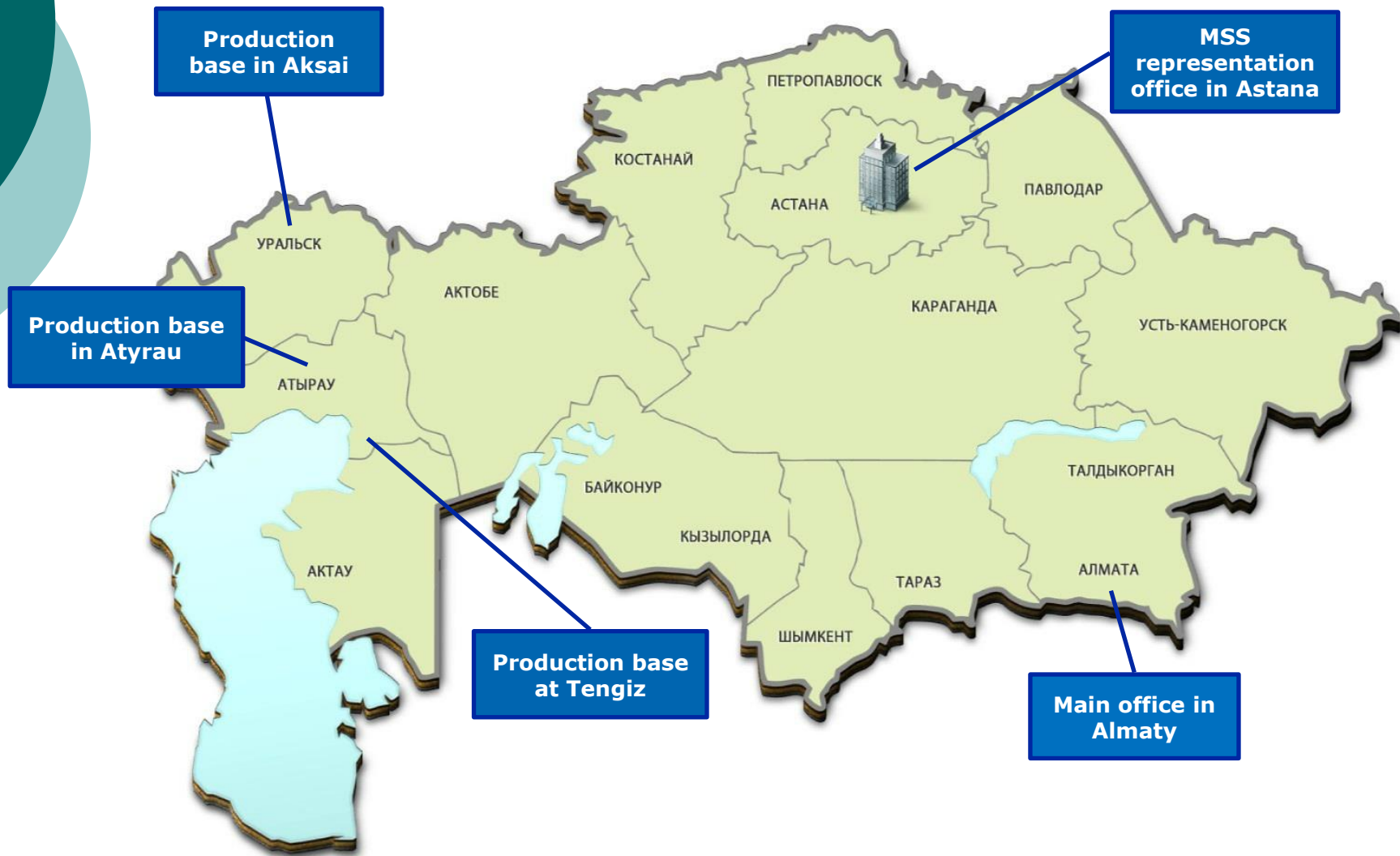
Steel structures of any complexity, including vessels (vertical and horizontal), mounting hardware and semi-finished goods for Instrumentation/Telecommunication equipment as well as custom-made articles and assembly components are fabricated in the facilities of Industrial Base for construction and installation works.

Currently, JS Company “Montazhspetsstroy” has operating Industrial Bases in the following regions of the Republic of Kazakhstan:

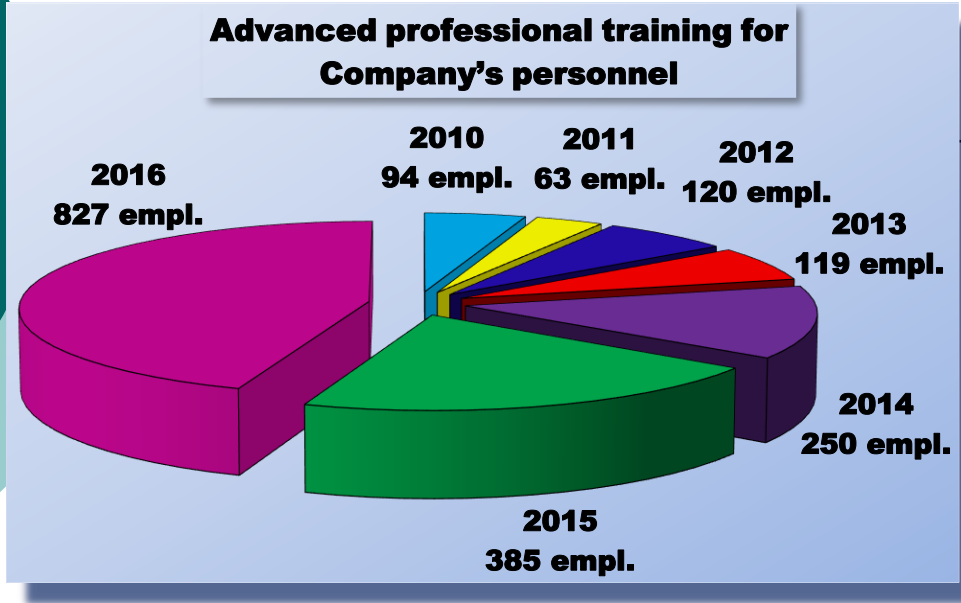
